**Electrical Amendments Per Ordinance: 2017-26**

(1) Minimum conductor size of all light and power circuits greater than 100 volts shall be no less than 12 AWG.

(2) No Aluminum Conductor smaller than 2/0 shall be used in the city.

(3) Armor Cable (Type A/C without an individual grounding conductor is prohibited.

(4) An accessible means of service disconnect shall be provided at the exterior of all buildings or facilities, directly next to the service meter or entry of the service conductors.

\$1,001 to \$50,000.....	\$35.00	For the First \$1,000.00 plus \$5.00 for each additional thousand or fraction thereof, to and including \$50,000.00.
\$50,001 to \$100,000.....	\$260.00	For the First \$50,000.00 plus \$4.00 for each additional thousand or fraction thereof, to and including \$100,000.00.
\$100,000 to \$500,000.....	\$460.00	For the First \$100,000.00 plus \$3.00 for each additional thousand or fraction thereof, to and including \$500,000.00.
\$500,001 and up	\$1,660.00	For the first \$500,000.00 plus \$2.00 for each additional thousand thereof.

**COMMERCIAL  
INSPECTION FEES**

When the valuation of Commercial Construction, Renovation, or Additions ( including all trade permits) is equal to or exceeds \$25,000, an additional inspection fee is due. Said Inspection fee shall be equal to the permit fee as set forth above.

**RE-INSPECTION FEES**

Repeated failure to correct previously noted inspection items may result in additional Re-Inspection Fees of \$75.00 (Per occurrence) being charged to the permit application.
