\$1,000 and Less.....	\$35.00	Minimum Permit Fee
\$1,001 to \$50,000.....	\$35.00	For the First \$1,000.00 plus \$5.00 for each additional thousand or fraction thereof, to and including \$50,000.00.
\$50,001 to \$100,000.....	\$260.00	For the First \$50,000.00 plus \$4.00 for each additional thousand or fraction thereof, to and including \$100,000.00.
\$100,000 to \$500,000.....	\$460.00	For the First \$100,000.00 plus \$3.00 for each additional thousand or fraction thereof, to and including \$500,000.00.
\$500,001 and up	\$1,660.00	For the first \$500,000.00 plus \$2.00 for each additional thousand thereof.

COMMERCIAL INSPECTION FEES

When the valuation of Commercial Construction, Renovation, or Additions (including all trade permits) is equal to or exceeds \$25,000, an additional inspection fee is due. Said Inspection fee shall be equal to the permit fee as set forth above.

RE-INSPECTION FEES

Repeated failure to correct previously noted inspection items may result in additional Re-Inspection Fees of \$75.00 (Per occurrence) being charged to the permit application.
