ORDINANCE NO. 2017-17**

**AMENDMENT TO THE OFFICIAL STREET MAP TO
RENAME LIDSTONE STREET TO LAKEWOOD YACHT CLUB DRIVE**

AN ORDINANCE AMENDING THE OFFICIAL CITY STREET MAP OF THE CITY OF SEABROOK WHICH IS PART OF THE SEABROOK CITY CODE OF ORDINANCES, CHAPTER 75, "STREETS, SIDEWALKS, AND OTHER PUBLIC PLACES", ARTICLE 2, "STREETS", SECTION 75-26, "STREET NAMING AND NUMBERING MAP", BY RENAMING "LIDSTONE STREET" TO "LAKEWOOD YACHT CLUB DRIVE", REQUIRING THAT THE "CITY STREET MAP" BE AMENDED TO REFLECT THIS CHANGE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the City of Seabrook has evaluated a request for the renaming of "Lidstone Street" to "Lakewood Yacht Club Drive", to more appropriately reflect and designate the characteristics of such street within the City; and

WHEREAS, all public notices have been published, mailed and provided in accordance with statute and the City Code of Ordinances; and

WHEREAS, the City Council has conducted a public hearing on such request, in the time and manner required by law; and

WHEREAS, the City Council of the City of Seabrook deems it in the best interests of the citizens to rename "Lidstone Street" to "Lakewood Yacht Club Drive";

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEABROOK, STATE OF TEXAS:

SECTION 1. FINDINGS.

The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

SECTION 2. AMENDMENT TO THE SEABROOK CITY CODE, CHAPTER 75, "STREETS, SIDEWALKS, AND OTHER PUBLIC PLACES", ARTICLE 2, "STREETS", SECTION 75-26, "STREET NAMING AND NUMBERING MAP".

That the City Council of the City of Seabrook hereby approves the renaming of "Lidstone Street" to "Lakewood Yacht Club Drive" for its entire length from NASA Parkway to Lakewood Pointe. The "City Street Map" shall be amended to reflect the renaming of "Lidstone Street" to "Lakewood Yacht Club Drive".

SECTION 3. REPEAL OF CONFLICTING ORDINANCES.

All ordinances or parts of ordinances in conflict or inconsistent with this Ordinance are hereby expressly repealed.

SECTION 4. SEVERABILITY.


In the event any clause phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part of provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Seabrook, Texas, declares that it would have passed each every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

SECTION 5. NOTICE.

The City Secretary shall give notice of the enactment of this Ordinance by promptly publishing it or its descriptive caption and penalty after final passage in the official newspaper of the City; the Ordinance to take effect upon publication.

PASSED AND APPROVED on first reading with a quorum present, by an affirmative vote of a majority of Councilmembers present, in accordance with Seabrook City Charter Section 2.10 on this 4th day of April, 2017.


