30 **4. DISCUSSION**

31 **4.1** Discuss, consider, and if necessary take all appropriate action regarding Hester Butterfly
32 Garden maintenance, signage, volunteer opportunities and volunteers for spring gardening.
33 *Member Harper*

34 Member Harper spoke with Saul Garcia, Park Superintendent, scheduling the parks crew to
35 use equipment to aid in clearing the overgrown vegetation at Hester Butterfly Garden after
36 March 20th. Chair Antrobus requested staff to research the name of the former organization
37 that originated the butterfly garden project for committee to contact and discuss the
38 organization's possible continued interest to provide two or more volunteer garden work days
39 a year. A list of native butterfly supporting plants will be needed. Member Harper will make
40 a list of what needs to be done for the committee to assist and reach out to volunteers. Once
41 a work day has been determined, Natalie Stephens, Public Works Admin Coordinator, will
42 send an email request to the volunteer list.

43 **4.2** Discuss, consider, and if necessary take all appropriate action regarding Eco-Star leaves
44 engraved in honor of Drusilla Carothers and Mary Milby for spearheading the idea of a trail
45 system within the Seabrook parks. *Chair Antrobus*

46 Member Antrobus read the following statement:

47 "The trails idea began to germinate in the late 1980s. By the early 1990s long-time resident
48 Mary Milby, serving on the Seabrook Parks Board, teamed up with her friend Drusilla
49 Carothers, who had recently come to live in Seabrook fulltime, to arrange for the Landscape
50 Architecture Department at Texas A&M University in College Station to organize a charrette
51 presentation and student competition to design the initial components of the Seabrook Trail
52 system.

53 Seabrook nurseryman, Joe Hester, owned what is now Hester Garden Park from 1925 to
54 1993. By the time Hester Garden Park was officially opened on April 24, 1994, the trails
55 network was in place through the former nursery property, an impressive new amenity
56 connecting the southern trails in Meador Park with the northern trails in Pine Gully Park.

57 Mary's interest was as a runner herself, living close to Hester Garden Park, and Drusilla's
58 interest was as owner of a large property sharing a long border with Pine Gully Park. In 2007
59 her property became part of the Seabrook park system, purchased via a bond vote after
60 Drusilla's passing in 2003 and now known as Carothers Coastal Gardens.

61 With support from Seabrook EDC, the trails have become ever more popular—enabling
62 hosting of the annual Lucky Trails Marathon, now in its 19th year; including several sites on
63 the Great Texas Coastal Birding Trail; and attracting visitors and residents alike to enjoy
64 nature and simultaneously improve their fitness.

65 We all owe grateful thanks to Mary Milby and Drusilla Carothers for embracing the trails
66 concept, negotiating the way to create the network, and riding herd on the early stages of the
67 project as the first trails were built."

68 Member Antrobus suggested each Eco-Star have supporting documentation on why an
69 individual or organization received recognition on the Eco-Star tree located at City Hall.

70 Member Antrobus requested staff search records for information on the dates of the start of
71 the Seabrook trail system for record purposes.

72 *Motion made by Chair Antrobus and seconded by Member Jones.*

73 *To recognize Mary Milby and Drusilla Carothers with gold leaves on the "Eco-Star" tree for*
74 *their foresight and leadership in spearheading the creation of the network of hike and bike*
75 *trails that so many people enjoy in Seabrook today.*

77 **4.3 Update on Pine Gully Pier and McHale Platform. City Staff**

78 Brain Craig, City Engineer/Asst. Public Works Director, stated a Request For Proposal (RFP)
79 and Request For Quote (RFQ) will be created to start the Pine Gully Pier project as well as
80 looking into grant opportunities. The City is referencing the City of Fulton's pier specs,
81 estimated cost around \$2 million. The City of Seabrook is reaching out to vendors for quotes
82 on demo and rebuilding with wood or filter through material. An RFQ will then be
83 submitted for an engineering report. Pine Gully Pier will likely have the same style but built
84 with different materials. The Pine Gully Pier was originally built with Texas Parks and
85 Wildlife Department (TPWD) grant funding. Pine Gully Pier is uninsured based on its
86 location. In the past, FEMA has assisted with eligible repairs, but not in this case. Chair
87 Antrobus suggested possible riprap style similar to Galveston jetties. Brain Craig, City
88 Engineer/Asst. Public Works Director will include an RFP rock option to present to City
89 Council.

90 Brain Craig, City Engineer/Asst. Public Works Director stated discussion on McHale's
91 platform had not begun yet.

92 **4.4 Discuss, consider, and if necessary take all appropriate action regarding Carothers**
93 **Community Garden. Member Jones**

94 Member Jones updated committee that currently there are 40 gardeners at the Carothers
95 Community Garden. Currently Carothers Community Garden has approximately \$1,400
96 from the 28 garden beds in addition to \$1,000 from a private donor. Volunteers have built a
97 few raised garden beds for ADA accessibility and staff has helped create a path that is almost
98 completely obstruction free for ADA access from the parking lot. Carothers Community
99 Garden is a member of Urban Harvest and can receive free plants, seeds and fertilizer.
100 Carothers Community Garden has orientation on Wednesdays and Saturdays for new
101 gardeners. Eagle Scouts 95 are working towards badges for Compost System, Pollinator
102 Garden and Weather Center projects. Cub Scout Pack 389 will have den meetings at the
103 gardens and learning about micro green planting. Staff has encouraged Carothers
104 Community Garden to apply for 501 (c) (3). Member Jones has filed for a 501 (c) (3) under
105 the name of Carothers Coastal Garden and will be responsible for filing tax returns. A

106 Carothers Community Garden has submitted a letter of intent with Port of Houston for a
107 grant to fund the garden murals.

108 **4.5** Discuss, consider, and if necessary take all appropriate action regarding design criteria
109 for HWY 146 landscape improvement. *Member Jones*

110 Member Jones discussed the Green Ribbon Program, City posted Bid Notice 2022-07,
111 requesting landscape architecture design services for SH 146 beautification. The
112 intersections being addressed are Red Bluff/Hwy 146, Meyer/Repsdorph/Hwy 146,
113 NASA/Hwy 146 and the Point/Hwy 146. Member Jones would like the committee to be
114 aware of the areas noted in the Green Ribbon program and the requirement for the consultant
115 to have one work session with OST and City Council for input. The committee discussed the
116 benefits of several low maintenance trees for a natural look rather than a rock area under the
117 overpasses. Member Jones will provide the OST committee a list of Houston areas with
118 ideal planting styles of Clark and Condon Associates.

119 **4.6** Discuss, consider and if necessary take all appropriate action regarding volunteer
120 coordination and projects. *Member Jones*

121 Member Jones requested OST committee provide lists of project tasks that can be shared
122 with volunteers. Scouts can help volunteer for future projects.

123 **4.7** Update and report on various Seabrook Park items, including needed repairs, signage,
124 plants, flowers and vegetation, and park use matters. *Committee*

125 Member Harper stated Scouts did a fabulous job clearing the bamboo from Hester Park with
126 the help of Member Popken.

127 **4.8** City Staff update and report on various Seabrook Park items including community
128 events, grant administration, repairs, Council approvals and determinations and emergency
129 events. *City Staff*

130 Kevin Padgett, Public Works Director, reported:

- 131 • Lucky Trails is scheduled for March 18-20. Parks Department has been working to
132 have all the trails ready for the event.
- 133 • Rivers, Lakes, Bays 'n Bayous Trash Bash will take place in person on March 26th.
- 134 • City has removed a few Tallow trees near Meador swale.
- 135 • City installed granite spur along Hester trail to lead to a primitive trail and a future
136 foot bridge made with reclaimed lumber. Member Harper asked if a small platform
137 could be installed near the small pond at Hester Park.
- 138 • Harris County continues to work on the outfalls from the drainage into Hester Gully
139 had failed where a sinkhole issue had come to their attention. Harris County removed
140 the soil pile and cane but will replace the sidewalk and guardrail. Member Harper

- 141 suggested Harris County create a safer water crossing at water level rather than the
142 narrow passage along Todville.
- 143 • Harris County is working on the outfall near Pine Gully Bridge. Member Coggeshall
144 inquired if the fence on the west side will be replaced in a manner to prevent cars
145 from pulling into. Kevin Padgett, Public Works Director, will check with Harris
146 County about fence location since it is along county right of way. Member Harper
147 inquired about future parking lot plans near the Todville Bridge. Kevin Padgett,
148 Public Works Director confirmed the parking lot project off of Todville near the Pine
149 Gully Bridge will be addressed by the CIP worksheets.
 - 150 • City has begun mowing approved areas such as the prairie. Staff is working with
151 Member Popken on flagging areas not to mow along Hester Gully and the pocket
152 prairie in Wildlife Refuge. Not to be confused with the flags near Robinson Park
153 prairie that are part of the geo study where temporary pipes are in place to monitor
154 water levels for the new lift station location.
 - 155 • The City has submitted a letter of intent to the Port of Houston Community Grant
156 Program for Wildlife Refuge trail head and Friendship park improvements. The
157 criteria has become more restricted by requiring grant funding be used no more than
158 1.5 miles from Port of Houston Ship Channel. The Wildlife Refuge trail head
159 qualifies by being less than 1.5 miles from the Bayport Ship Channel. This restriction
160 will limit submissions and perhaps increase the City's chances to be awarded the
161 grant.
 - 162 • Keep Texas Beautiful granted Keep Seabrook Beautiful the Gold Star status. The
163 City continues to wait for GCAA results. The city is eligible for receiving the award
164 as well as Sustained Excellence with a score of 90 or more.
 - 165 • The berm trail project funded by the TPWD grant will begin working from 146
166 towards the berm where a low lying foot bridge will be installed. Member
167 Coggeshall looks forward to a walking event once the trail is completed.
 - 168 • Clearing along Red Bluff is part of the sanitation sewer lines from Bayview lift
169 station to pump towards the new waste water treatment plant.

172 201 volunteer hours were reported for the month of January by Open Space and Trails,
173 Carothers Community Garden, Community Service and park volunteers.


175 The next Open Space & Trails meeting will be held tentatively on April 7, 2022 at 5 PM.

185 emergency events. *Staff*


