16 Chair Sally Antrobus called the meeting to order at 5:17 p.m.

17 1. **PUBLIC COMMENTS AND ANNOUNCEMENTS**

19 2. **COMMITTEE BUSINESS**

21 **2.1 Discuss and recommend types and uses of bird feeders within City parks.**
22 **(Committee/City Staff)**

23 Kevin Padgett, Director of Public Works requested recommendations from Open Space and
24 Trails committee on improved bird feeder design, at Pine Gully and Robinson park, specific
25 to birds and proper food.

26 Dwayne Vanselous, Animal Control Supervisor, spoke on the importance of providing a
27 proper diet for the local and migratory birds that is conducive to their good health. He has
28 seen several birds become sick and almost die due to eating the wrong food. Dwayne
29 Vanselous reported the Houston Audubon Society provides a list of foods that are
30 detrimental to birds such as bread and human food/table scraps due to poor nutritional value,
31 mold and bacteria issues. The Houston Audubon Society recommends funnel shape feeders
32 if peanuts are being provided. Dwayne Vanselous recommended that due to the many bird
33 watchers that come to Seabrook parks that we make sure to protect the bird population's
34 health with allowing the City to regulate and provide approved bird food.

35 The following comments were made by committee and staff:

- 36 • Suspended bird feeder.
- 37 • Catch tray underneath feeder.
- 38 • Tray feeder with perforated bottom and roof design.
- 39 • Tray feeders promote bird diseases without regular cleaning.
- 40 • Simple feeder design for simpler cleaning.
- 41 • Proper bird food in small containers sold by Animal Control.
- 42 • Some birds like to forage on the ground for food.
- 43 • Feed on the ground attract rats, snakes and other wildlife.
- 44 • Feed is only supplemental.
- 45 • Planting for sustainable food instead of feeders to address concerns of feed type,
46 dependency and schedule.
- 47 • Maintain both feeders and bird friendly planting.
- 48 • Need professional recommendations from Audubon or Texas Park and Wildlife.

50 *Committee request the Audubon Society to assist with bird feed and feeder issue.*

53 **2.2 Update on Harris County Miramar subdivision drainage improvement co-op project.**
54 **(City Staff)**

55 Kevin Padgett, Director of Public Works, reported on the Harris County proposed partnership
56 project with the City of Seabrook addressing some of the drainage issues within the Miramar
57 subdivision. Harris County's recommendation would benefit only 30% of the home in
58 Miramar subdivision. City Staff and City Council decided that the cost and environmental
59 impact of the proposed project was too great to move forward at this time. The drainage
60 improvement is still within the City Capital Improvement Projects (CIP).

61 **2.3 Discuss Plant Swap at Clear Lake Park on May 22nd. (Committee/City Staff)**

62 Chair Antrobus stated Kevin Padgett, Director of Public Works, has registered the City of
63 Seabrook for a booth at the Clear Lake Plant Swap on May 22nd from 8-11 AM, set up at 7
64 AM. She requested that the committee gather plant clippings and seedlings and attend the
65 Swap event at 8 AM. City will provide informational handouts from Keep Seabrook
66 Beautiful and a canopy.

67 **2.4 Discuss Monarchwatch.org Milkweed grant. (Committee)**

68 Chair Antrobus reported the City of Seabrook may be eligible for the Milkweed Grant
69 sponsored by Monarch Watch. The grant is for up to 2,000 milkweed plants that would
70 benefit butterflies. The criteria for the grant is for location to be non-pre-existing landscaped
71 areas such as Wildlife refuge, Pine Gully, and Robinson Prairie. Three perennial milkweed
72 species are being offered and only the cost of shipping is required. Chair Antrobus suggested
73 a milkweed planting day in spring 2022 for volunteer help. Vice Chair Popken requested
74 Kevin Padgett to get approval from the City to apply for the Milkweed grant.

76 **2.5 Update on grants. (City Staff)**

77 Kevin Padgett, Director of Public Works, stated the Texas Parks and Wildlife grant, which
78 was approved and awarded last year, is still in the environmental research portion of the
79 process. The City applied for a Port of Houston Community Grant in April for the Wildlife
80 Refuge trailhead project. The City has received a response from Port of Houston stating the
81 application has been received.

82 Member Coggeshall inquired if Keep Seabrook Beautiful will be eligible to be awarded the
83 GCAA grant this year. Kevin Padgett confirmed Seabrook is eligible to win the Governor's
84 Community Achievement Awards 2022 since the Gold Star status was maintained. Member
85 Harper inquired if there were available funds from the GCAA Grant last awarded to
86 Seabrook. Kevin Padgett stated the funds awarded from that grant was applied to
87 landscaping embellishments along TXDOT corridor at completion of the Hwy 146 expansion
88 project. Kevin Padgett requested City staff and Open Space and Trails committee further
89 discuss which projects they would recommend the GCAA Grant 2022 funds to go towards
90 prior to submission. The GCAA Grant has project categories eligible for funding. Chair
91 Antrobus suggest taking time now to focus on gathering data and images and start
92 customizing committee's efforts to qualify for grant opportunities.

93 Member Popken inquired on status of completed webinar hours for Keep Seabrook Beautiful
94 annual reporting. Kevin Padgett stated that City staff and Open Space and Trails members
95 can participate in webinar trainings to include on the annual Keep Texas Beautiful affiliate
96 report.

97 **2.6 Update on Story Walk signage. (City Staff)**

98 Kevin Padgett, Director of Public Works stated the Story Walk Signage has been approved
99 by Harris County Commissioners, Mayor of Seabrook and Harris County Judge Hidalgo.
100 Construction should be commencing soon.

101 **2.7 Update on parks' status or issues. (Committee)**

102 Chair Antrobus stated that plants which survived the freeze are starting to come back. This is
103 a good opportunity to rid of the dead plants and plant better plants.

104 **2.8 Update on Volunteer Hours (Committee)**

105 Committee members will submit their monthly volunteer hours to Natalie Stephens for
106 record keeping.

107 **2.9 City Staff update. (City Staff)**

108 City Staff had not additional updates.




121 By Committee consensus, the following will be added to the June agenda:
